SUBJECT: Responsible Official Certification In ePermitting

TO: All Title V (Part 70) Permit Holders

This memorandum is to clarify the Responsible Official certification process for all Title V (TV) permit holders in the SCDES ePermitting system. As we transitioned to the ePermitting system, we contacted each TV facility to confirm if the Responsible Official (RO) listed in our database is up to date. If necessary, updated RO documentation was requested and entered in ePermitting. After completing our updates, each RO was asked to submit an ePermitting Certifier Agreement and was emailed an invitation allowing access to air files in ePermitting. The agreement will be retained on file as the final "wet ink" signature and satisfies the EPA requirement for acceptance of electronic submittals. All ROs that have submitted an agreement to the Air Permitting Program will see "Administrator (Certifier status Approved)" under Authorized Users in the system.

Going forward, reports and forms requiring submission with a Responsible Official signature will include the window in the screenshot below. For air permitting, this will be added to our construction permit form, 502(b)(10) form, and the Title V applications (new, renewal, and modification).

How do you qualify as a Title V Responsible Official?*

This will replace the D-2951 Form to add, remove, or update RO information. The RO will enter their information and select the role that qualifies them as a Responsible Official.

Please note, new ROs will need to submit a certifier agreement form with wet ink signatures by mail prior to submitting reports and forms in ePermitting. At some point in the future, a facility with multiple permits in different media will be merged together and this change will assist with this transition.
