I updated the initial acreages, but did not adjust the "add land" box, making the new permitted areas incorrect. This has been revised.

#### Description

The purpose of the permit modification is to 1) update the current acreages to reflect an updated land survey completed in 2023, and 2) add two parcels to the mine permit, 3) modify current buffer area to affected area.

1) Previous permit acreages are based off Spartanburg County tax records: affected acreage of 70.8 AC, buffer acreage 48.5 AC, and 0 AC future reserves, totaling 119.3 AC. The 2023 land survey indicates corrected acreages: affected of 72.4 AC, buffer of 38.6 AC, and total of 111.0 AC within the current permit boundary.

2) The two parcels, 5-34-00-016.00 located off Brockman McClimon Rd. and 5-34-00-020.11 located off E. Howell Rd., are to be added to the mine permit, increasing the total permitted acreage by 9.9 AC.

3) A portion of current buffer acreage east of the existing pit will be modified as affected acreage.

The proposed changes will result in a total permitted acreage of 120.9 AC, comprised of 82.2 AC of affected area and 38.7 AC of buffer area.
