Dear Mr. Dempsey:

The South Carolina Department of Health and Environmental Control (DHEC) has reviewed the referenced report and offers the following comments and/or recommendations:

1. Due to the elevated water table at the site, gauging for the presence of free phase product (FPP) will continue across the site and any FPP found will be removed.
2. If there is a change in site conditions such as increased product levels, product in areas that product was not previously found and/or product appears on surface waters, a new corrective action plan to address the product will need to be submitted and/or more frequent monitoring may be required to address any issue that arises.
3. The Conceptual Site Model will be updated to include data from subsequent assessment and remediation activities.
4. The Quality Assurance Project Plan (Revision 6) has been reviewed and approved.
5. The 2025 Groundwater Monitoring and Reporting schedule will be reviewed and updated if necessary, during the 4<sup>th</sup> quarter of 2024.

**In the future any proposed changes to the Corrective Action Plan Addendum (CAPA) must be provided in a stand-alone document. The reviewing of monitoring reports or any other miscellaneous documents provided by Products (SE) Pipeline or Jacobs that discuss changes to the CAPA do not constitute approval of changes to the CAPA.**

DHEC should be notified a minimum of 4 days prior to any environmental work being conducted. All documents and correspondence should reference Site ID #18693. Documents should be provided in paper format. If substantial in size, a pdf via disk should be submitted.
