## **HHPD Rehabilitation Grant Sub-Award Application**

Instructions for Completing DHEC 4132

**PURPOSE:** This form is used to gather information concerning projects eligible for funding from SCDHEC through the US Department of Homeland Security – Federal Emergency Management Agency's High Hazard Potential Dams (HHPD) Rehabilitation Grant Program. This form alone does not constitute an application for funding under the HHPD Rehabilitation Grant Program. Supporting documentation as described in the SCDHEC Notice of Funding Opportunity (NOFO) is also required to constitute a complete grant application.

## **INSTRUCTIONS:**

- **1. Project Sponsor:** A project sponsor is a state agency, county government, municipal government, special purpose district, other non-federal government organization, or a non-profit 501(c)(3) organization.
- **2. Sponsor Address:** Mailing address of the project sponsor.
- **3. Sponsor Representative and Title:** The name and title of a person employed by the sponsor that has signatory authority for the sponsor and that may be contacted concerning the proposed project.
