 - 3. Enhance collaboration between all stakeholders and water interest groups, including Georgia and the Lower Savannah-Salkehatchie River Basin. (September 2023)

Meeting Summary (September 11th)

Jill Miller, USRBC Chair, called the September 11th meeting of the Upper Savannah RBC to order at 10:00 AM. The thirteenth meeting of the Upper Savannah RBC was held in-person and virtually via the Zoom virtual meeting platform. Including the Upper Savannah RBC members and planning team, there were 32 people present at this RBC meeting in-person and online. Jill discussed the agenda items for the meeting. The Upper Savannah RBC approved the RBC meeting agenda and the minutes and summary documents from July. A public comment and agency comment period was held with no comments received. Ashley Reid reviewed the July meeting highlights. John Boyer provided a brief introduction to draft Chapters 2 and 3 of the Upper Savannah River Basin Plan.

Ashley Reid and John Boyer, CDM Smith, facilitated additional discussion with the USRBC members on planning process recommendations. The RBC members went through draft recommendations and chose green, yellow, or red buckets that indicated approval, the need for more discussion and refinement, or getting rid of certain recommendations. The items discussed included: engagement planning, elected officials serving on the council, membership, future scope of the RBC, collaboration with other RBCs, process of updating the State Water Plan, continued funding, grant program, and discussion of AgWRAP in NC.

Next, the RBC discussed technical recommendations for the plan. The discussion focused on modeling, sedimentation, stream gages, and a mesoscale network.

Joe Koon and Hannah Hartley, SCDES, discussed the role of SCDES in water planning and a refresher of water withdrawal law and regulations in SC. Joe discussed the water resources division, changes to be aware of, and the plan to keep moving forward on the River Basin Plans and State Water Plan. Hannah discussed the SC Surface Withdrawal, Permitting, Use and Reporting Act which included relevant regulation, permitted and registered volumes (safe yield and minimum instream flows), existing withdrawer criteria, new withdrawer criteria, and agricultural registration criteria.

The meeting concluded with Ashley Reid and John Boyer discussing the next Upper Savannah RBC meeting which will be held at the Starr Iva water district office. The RBC members were tasked with starting to think about Broad RBC recommendations and then think through possible Upper Savannah water law and regulation recommendations. The next meeting will be held October 9, 2024.
