Dear Will Glusac:

A Notice of Intent for coverage under a general NPDES Permit was received on November 8, 2023. Your facility has been assigned General NPDES Permit number SCG731699. All correspondence should reference this General NPDES Permit number. A copy of the General Permit for Discharges Associated with Nonmetal Mineral Mining Facilities is available at: <u>SCDES General NPDES Permits</u>. You are responsible for complying with the conditions of this permit. This facility is required to submit Discharge Monitoring Reports (DMRs). The DMRs and the associated DMR letter are enclosed.

In addition to this NPDES general permit coverage, this project may be required to obtain other permits before mining may begin. Mines, other than borrow pits for SC DOT or SC Ports Authority projects, are required to obtain a mine operating permit. Mine operating permits are issued through the Division of Mining and Solid Waste Management in the Bureau of Land and Waste Management. When you begin construction of this new mine, please inform the SCDES stormwater inspector for the SCDES Region in which the mine is located. To obtain the telephone number, please click on the correct Region at the following link. <u>SCDES Local Offices</u>.

General Permit coverage is effective on July 11, 2024. S.C. Code Ann. § 48-6-30(D)(2) provides, "Within thirty calendar days after the mailing of a decision [pursuant to S.C. Code Ann.§ 48-6-30(D)(1)], an applicant, permittee, licensee, certificate holder, or affected person desiring to contest the department decision may request a contested case hearing before the Administrative Law Court, in accordance with the Administrative Procedures Act."
