

NOTICE OF PUBLIC HEARING

Luck Stone Corporation
Luck Saluda Quarry
Saluda County, South Carolina
(DHEC Application I-002404)

Date: October 26, 2023

Luck Stone Corporation has applied to DHEC for a permit to mine granite at a site located on Double Bridges Road in Saluda County, approximately 5 miles northwest of Batesburg-Leesville, South Carolina (TMS #174-00-00-006). A proposed reclamation plan to restore the site to grassland and lake/pond has been submitted with the application. The mine permit application and related documents are available for review on DHEC's website at www.scdhec.gov/LuckStoneSaluda.

DHEC will hold a **public hearing on November 30, 2023, at 7:00 PM**, to accept oral and written comments on the proposed quarry. A **public meeting will be held from 6:00 PM until 7:00 PM prior to the public hearing**. These events will be held at **The Venue at West Creek** (160 Plantation Ln, Batesburg, S.C., 29006). Doors will open at 5:30PM to facilitate the sign-in process and provide an opportunity to meet DHEC staff.

The public meeting is informal and provides an opportunity to have a discussion with DHEC staff about the quarry and environmental permitting process prior to giving comments at the public hearing. The meeting will begin with a DHEC presentation followed by a time to ask questions.

The public hearing is formal and provides an opportunity to make oral comments that will be heard by DHEC staff and recorded by a court reporter. **There will be no questions and answers during the public hearing.** DHEC values each participant's involvement in the public hearing and will conduct it in a respectful, orderly manner with reasonable limits on the length of comments, if necessary.
